Hello OCDSB Trustees,

I appreciate the opportunity to explain our family's story, for your consideration.

We just, on February 28, after nearly 2 years, sent our 5 year old to in-person school, and our 2 year old to daycare. We had kept everyone at home at tremendous cost to our family because I am at risk of severe COVID. With our mental health fraying, all but the youngest vaccinated (and vaccine for her months away at best), and omicron seemingly on the downswing, but certainly not gone, we finally felt comfortable to increase our risk. We did not, however, sign up for an unmasked school environment, at least not so soon. We did not anticipate an unmasked community feeding into the school system so soon. Some of the safeguards we relied upon to make this decision are being lifted without debate, in direct conflict with the advice of trusted experts.

I urge you to consider acting on whatever is within Board authority to keep students, staff and families - many of whom are still vulnerable to this virus - safe until we have a lower level in the community.

Thank you for holding this meeting, and for considering the challenges these circumstances present for many vulnerable families.

Hi,

The indoor mask mandate in schools should be lifted in schools after the March Break. Students and Staff have had enough of the masks for 2 years. It is time for them to come off completely. Please provide a brief summary of main points for the issue/concern:*

Written delegation: The dropping of mask mandates is not unexpected. It is not coming out of left field, at least not to anyone who has been paying the least bit of attention. The majority of European countries, all US states, and now several Canadian provinces are dropping their restrictions. The pleas of "why so soon" are disingenuous. What will have changed 2 weeks after March break? We do not need the extra time so the schools can "prepare" the students. As their parents, WE are in the best position to prepare them, and thankfully we have a whole week ahead of us to do so. I understand that some see the school board as the last resort to save them from other children's unmasked smiles, but this is not the board's place.

I see a lot of concern that the children who choose to remain masked may become victims of bullying. I have yet to learn of a single example of this from any of the many places that have removed their mandates, but I'm sure there must have been some isolated incidents. What I have seen, however, are teachers from the GTA and probably beyond openly discussing online their plans to segregate (their word, not mine), guilt trip, isolate, and shame their students if they come to class unmasked. One teacher outright threatened their students with what amounted to a subpar education (I believe the tweet said no hands-on or group work, expect a lot of writing sheets since you won't be able to hear me anyway through my double-masks). Is this acceptable? I sure hope not. But I would propose that turning the question of when to remove mask mandates into yet another battle that must be fought between those who are ready and those who are nervous, as opposed to the next step we take as a community toward a more normal existence that is long overdue for the youngest members of our society who have shouldered a disproportionate burden, contributes to the climate that allowed these teachers to believe that they were in the right to write such vile things.

Recommendation(s) for resolution of issue:*

Thankfully, anyone who is concerned about transmission can purchase N95's. A properly-fitted N95 is highly effective at protecting the wearer, and does not rely on the behavior of others around you for protection. High-quality one-way masking is more effective at protecting the vulnerable than universal use of low-quality masks. I assume that this is why teachers pushed so hard for the province to provide them in January.

I don't think that there is a single serious doctor out there today who still thinks that covid can or will be ever eliminated. It will be with us forever. Restrictive policies increase fear & falsely convey that schools are unsafe. This increases harm to student mental health, which can have major detrimental effects. If you are successful in implementing a board-specific extension to the masking mandate, school will be the only regularly frequented place where children are forced to wear a mask. But as soon as the bell rings, they will go over to each other's houses, they will visit family and friends, attend their extracurricular activities or part-time jobs, go to malls & restaurants & events- unmasked. They do not disappear when they are not in school. So what difference does it make, really? Is this helping them learn to read? Is this teaching them to accurately identify each other's emotional cues? Or does it passively teach them that their joy and their smiles are not worth seeing?

It's time to let this one go.

The decisions trustees at OCDSB have made throughout the pandemic have set precedent in Ontario and have directly led to the Province having safer schools. Thank you.


In February 2018, my perfectly healthy, influenza-vaccinated 2.5 year old son was hospitalized for Influenza B. He spent 7 days in CHEO and fortunately recovered - but, in an instant, our family became that "very unlikely case." We were statistically rare, and lucky, but the reality of seeing a child that ill that quickly is etched forever in my mind. Even at very low percentages, *it's someone's child*. Now in 2022, he is a very healthy 6.5 year old, with no underlying conditions - but kids get COVID; vaccinated kids get COVID and previously-infected kids can get COVID again. Neither infection nor vaccination reduces your chances of getting COVID to zero. BUT, masking, especially with high quality masks - (*almost*) DOES!**...and any mask is better than none:

(**aside, the long-term solution would be to clean the air we breathe, similarly to how we developed water-treatment solutions in the time of cholera. Since COVID isn't going anywhere, it's time for engineering solutions to clean the air we breathe)

But then people say: "Why try to stop people from getting covid if those who are vaccinated and those who have had COVID can get it again?"

BECAUSE LONG-COVID and LONG TERM SEQUELAE from even asymptomatic or mildly symptomatic cases. A recent study shows that 25% of covid infections in children and adolescents leads to long-COVID. That's a lot of kids. Article here: https://www.medrxiv.org/content/10.1101/2022.03.10.22272237v1



Research (listed at the end) shows *ANY* covid infection can have *lasting* heart/liver/kidney disease; brain damage/loss; increased incidence of strokes/clotting issues; sustained lung damage; increased Type 1 diabetes; fatigue/memory/concentration issues; MISC in children.

Did you know that previous infection with HPV16 or HPV18 is the leading cause of cervical cancer? Chronic H. pylori infection leads to stomach cancer? Previous chickenpox infection can induce shingles later in life? Public Health should be advocating for individuals to try to NOT get the virus - and certainly not multiple times. Multi-layer approach is still required:

vaccine + mask + clean/filter the air + control transmission = success.

Dismantling COVID protections won't bring us back 2019. In the absence of testing, tracing and with shortened isolation, **MASKS** are the last universal protection that schools and WE have. The world has changed and COVID is not over despite what you are hearing from our government and the Chief Medical Officer of Health.

Ontario has chosen to prioritize the economy despite strong, countless studies that COVID harms many people, even those without hospitalization. Vaccination prevents against death, but not against long-term damage. Your first COVID infection can leave you with pre-existing conditions that will make you more vulnerable to subsequent infections. This is why **WE MUST CONTINUE TO CARE AND CONTINUE TO PROTECT OUR CHILDREN!**

Most of Europe dropped all COVID protections 4-6 weeks ago and we are now seeing the start of wave 6. We are no different here in Canada and Ontario and we will see the same thing if we don't keep any mitigations in place.

Reasons to keep masks:

- 1. Kids under the age of 5 are unvaccinated. Completely susceptible to long-COVID and long-term COVID sequelae
- Kids between 5-11 have considerably lower vaccination rates than those 12+ across Ontario
- 3. New evidence suggests significant waning of vaccine in 5-11 year olds after only 5 weeks after the second shot (most in this age group would be 5 weeks+ now)
- 4. Students/staff do not exist in a vacuum some students have immunocompromised siblings, parents, grandparents.
- Long-covid risks from ANY covid infection. Mounting evidence suggests significant sequelae and long-term implications of even asymptomatic or mildly symptomatic cases - heart/liver/kidney disease; brain damage/loss; increased incidence of strokes/clotting issues; sustained lung damage; increased Type 1 diabetes; fatigue/memory/concentration issues; MISC in children.
- 6. Masking is the simplest measure to keep in place.
- Universities and private schools are keeping masking because they know it works; they don't want disrupted school settings and they are protecting their staff, students and community

Please provide a brief summary of main points for the issue/concern:*

I would strongly urge the members of the Board to ensure that masks are mandatory on school property after March break. My son is 4 years old and I have a daughter that is 14 months. We all got COVID in 2021. My daughter was just 4 months old at the time, my son was three. Their father was almost hospitalized, and while the kids exhibited generally mild symptoms, nothing has been more terrifying as a mother than to watch your newborn and toddler go through this while worrying about what happens if you get too sick to care for them. We have no family and no support here in Ottawa. Our kids are too young to be vaccinated yet.

My son has grown up knowing that putting your mask on is part of getting ready for school, it's like putting on your mittens or your sunscreen. It's normal to them now. If he sees the older, vaccinated kids removing their masks, he will want to do it too. It's like watching Pokemon, or playing rough in the school yard. He wants to be like the older kids in his class. I would ask that masks be in place until all little kids can get vaccinated.

I have seen a lot about people doing what's "Comfortable for them" and to "assess their own comfort levels" but teachers, students, crossing guards - their masks protect my son too when he's in close contact with them. It's not just their comfort level, it's about the whole community. We protect each other

Please provide a brief summary of main points for the issue/concern:*

Dear trustees,

I am very concerned about the plan to remove mandatory masking in schools on March 21st. My 5-year-old is in SK. Given the low vaccination rates for the 5-11 age group and that there is currently no vaccination available for kids under 5, it is likely that only a quarter of the kids in his class are vaccinated for covid. Masks are an essential layer of protection in reducing the spread of covid in our schools, and they work best when everyone is wearing them. We also have a 2-year-old at home who is too young to get a covid vaccine.

While of course, we all want our kids to get back to having a normal school experience, many scientists and experts have warned that March 21st is too early to remove mandatory masking. Dr. Peter Juni, scientific director of the Ontario COVID-19 Science Advisory Table, and the Children's Health Coalition, a collective of children's health organizations in Ontario, have both said that March 21st is too soon to remove mandatory masking.

It is my hope that OCDSB will choose to listen to the science and prioritize the health of our children by keeping mandatory masking in schools for a little longer.

Recommendation(s) for resolution of issue:*

Extend mandatory masking until at least mid-April, with a plan to review the covid situation at that time.

Please provide a brief summary of main points for the issue/concern:*

Understanding that the board is in a position to have to respond to provincial direction as the lifting of covid protocols, I would like to know what the school board is doing to help protect kids who have not yet been able to get vaccinated? Ontario Universities have decided to keep mask mandates in place until the end of the term (with their student population having a vaccination rate around 98%). Will the school board also do the same to protect their students with a much lower vaccination rate?

Recommendation(s) for resolution of issue:*

Option 1 - follow the same direction as Ontario universities and maintain covid safety protocols, including masks, until the end of the term or when a reasonable amount of time has passed to determine the impact of these changes.

Option 2 - have kids under 5 adhere to masking and other covid safety measures (cohorting, sanitizing, screening) until the end of the term.

We have reason to be cautiously optimistic. Let's guard our gains.

Please provide a brief summary of main points for the issue/concern:*

I am writing as a parent of a junior kindergarten student who, like many of his classmates, is not eligible yet for vaccination due to age. My son, like many of his classmates, has a younger sibling at home who also cannot be vaccinated yet and is at higher risk of severe illness.

I am deeply concerned about the provincial plan to no longer require masks in schools. This change is contrary to the recommendations of the Children's Health Alliance which is made up of children's hospitals in Ontario, including CHEO. The Children's Health Alliance released a statement on February 28, 2022 calling for masking in schools to be maintained. The statement acknowledged that masking remains an important layer of protection and is still required to protect children and their families. Since that date, the Children's Health Alliance has released two additional statements calling for masking to be maintained in schools for a minimum of two weeks after March Break to allow time to assess the impacts of relaxing other public health measures.

Despite these recommendations, and a previous statement by Ontario's Chief Medical Officer of Health that masking may continue longer in schools than other settings to maintain confidence of parents, staff, and students, the province is proceeding recklessly by lifting the school mask mandate on March 21, 2022. This decision will subject students, staff, and their families to unnecessary risk.

Throughout the pandemic, the risk to children has been minimized by decision makers. However, COVID-19 continues to present a risk to children, particularly those too young to be vaccinated. Sadly, 13 Ontarians aged 19 and under have died due to COVID-19 and 1279 have been hospitalized.

Further, the Government of Canada has acknowledged that a significant number of children may be affected by "post-COVID condition" with about 58% of children reporting at least one symptom more than 4 weeks after their initial COVID infection.

Recommendation(s) for resolution of issue:*

(cont'd) These symptoms can include fatigue, headaches, sleep disturbances, and difficulty thinking or concentrating. It seems plausible such symptoms would have an impact on student performance.

In addition, it is not clear yet what long-term health consequences infection with COVID-19 may have. Many viruses have been found to result in serious health issues years later (ex. HPV causes several types of cancer, mono is associated with multiple sclerosis, etc). When it comes to the health of children, decision makers should take a precautionary approach to minimize the risk of infection.

While masking may still be encouraged after March 21, some will discontinue mask use and that will increase the risk for those around them. Two-way masking has been shown to be more protective than one-way masking. Further, parents who want their children to continue masking may encounter resistance when peers stop wearing masks. Others may see increased anxiety in their child around attending school once masks are no longer required as I expect to see with my son.

As a parent of two young children through this pandemic, I have felt the weight of decision fatigue from the constant need to evaluate the risks and benefits of activities. The recent provincial announcements have again left me weighing the risks to my children's health against the benefit of in-person learning.

I strongly believe the school board should do everything in its power to ensure masking continues in schools after March Break to protect students, staff, and their families. It is worth noting that the requirement for masking in kindergarten was a result of action by the OCDSB Board of Trustees and not a part of the provincial mandate. As many kindergarten students remain too young to be vaccinated, it is particularly important for the Board to clarify whether that requirement will still be in force on March 21, 2022.

Dear OCDSB trustees,

I am writing to you today to encourage you to continue the requirement of masking in schools until at the very least 2 weeks after the end of March break so as to allow for a bare minimum of time to assess the impact of both the break, and the growth of BA.2 in Ontario before stripping students and staff of their best physical defence against COVID.

As I'm certain you're aware, the decision to end school mask mandates is not one supported by science as is evidenced by the fact that both the Ontario Science Table and the Children's Health Coalition have described the move as premature and have warned that following through on same will risk in person learning and child well-being.

The removal of school mask mandates risks all students and staff as the preponderance of evidence identifies universal masking as beneficial in decreasing COVID's airborne transmission. Removing school mask mandates would also increase inequity by putting those children who are themselves immunocompromised or otherwise vulnerable to more severe courses of acute illness at greater risk, as well as risking the families of students who live in multigenerational homes, or in homes where a parent or sibling themselves are immunocompromised or are at otherwise heightened risk of more severe acute courses, or in homes with children under 5. It will also likely lead to bullying of those children who continue to mask for themselves and others.

We shouldn't only look to severe outcomes though. We can't and don't know the long-term risks of even mild courses of COVID on children as here we are discussing a disease that has only existed for just over 2 years. Assuming that there won't be long term consequences is unwise given both the experiences currently being reported in both adults and kids with lingering courses and complications, but also from other viral illnesses that in turn lead to long term complications that could not have been predicted without the benefit of decades of surveillance and research like for instance with cervical cancer and the human papilloma virus.

Ontario is also hamstrung in understanding our current disease burden due to our marked purposeful reduction in available symptomatic testing, our lack of contact tracing, and our lack of a mechanism through which to report our positive rapid test results. Currently our percent positivity is on the upswing as are hospitalizations, and despite markedly lowered test numbers, we're still documenting more positive daily cases than we did at the peaks of all pre-Omicron surges where testing capacity had been preserved. There are also more deaths from COVID each day in Canada right now than there were on an average day in 2021. As to the "mildness" of Omicron – one third of the past 26 months of this epidemic's most severe outcomes have been reported over the past 3 months.

Our best defense against COVID, vaccination, has stalled at 2 doses for nearly 50% of 12+ children and while our 5-12 year olds see an 86% rate of 2 doses, they have yet to be offered

access to 3rd doses. And while 3rd doses do appear to be crucial in helping to reduce risk of both contracting and transmitting COVID, we also know that immunity wanes with the real likelihood now looking as if within 3-6 months, the benefits from those 3rd doses will be markedly diminished. What doesn't diminish however, is the ability of masks, especially higher quality masks, to reduce risk, nor would we ever expect it to as regardless of the evolution of future variants, they won't evolve a way to defeat the laws of physics.

It is also worth pointing out that viruses do not preferentially evolve to become less virulent and given our markedly decreased surveillance due to our markedly decreased testing and virtual elimination of contract tracing, continuing with masking may help blunt our inevitable next surge. I say inevitable purposefully as we have since day one had the advantage of a global crystal ball to see what's coming, and China, our original bellwether, is once again closing schools and locking down cities.

And it's not just China. COVID rates were reported as rising in 21 countries yesterday, up from a rise in 13 countries on March 5th. Some countries who opened things up as widely as we now have here are experiencing marked upticks in hospitalizations and deaths including more highly boosted Denmark, Finland, and the UK. Average daily deaths by the way, are rising again in Canada as well.

And of course, wholly unsurprisingly, there are reports of new variants – and while most will not amount to much, it's only a matter of time before something new truly takes over, and with all protective measures removed, minimal surveillance, and a government seemingly putting politics ahead of public health, it will likely rip through our unprotected schools and community.

Schools who can, seem to nearly uniformly be continuing to require masking – from universities to private elementary and high schools, and though I'm not a lawyer, Professor Attaran has noted that which is not prohibited by the Education Act is allowed, like dress codes, and the Education Act has not been amended to prohibit mandatory masking. I have also heard it proposed that school boards may be named in lawsuits on behalf of parents who can't arrange virtual schooling for the rest of the year and have a reason to require a mask free classroom.

While we all want this nightmare to be over, prematurely pretending that it is will only make it worse – both in the near term with what will inevitably include a surge in BA.2, and in the mid to late term when the next variant hits. Schools certainly should be the first to open and the last to close, and maybe if school boards in fact did what they could to protect their students' and staff' safety they would be (and while I still have your attention, maybe someone can move to allow for the fundraising, purchase, sale, and use of inexpensive Corsi-Rosenthal boxes to help).
