Appointment of Association Representatives and Alternates to the Special Education Advisory Committee

PURPOSE:

1. To appoint association representatives and alternates to the Special Education Advisory Committee (SEAC) for the duration of the term of the Board, 03 December 2018 to 14 November 2022.

CONTEXT:

2. The composition of the Special Education Advisory Committee is outlined in sections 4.1 to 4.3 of Board Policy P.019.GOV: Special Education Advisory Committee (attached as appendix A). The membership is currently comprised of three trustees, nine associations and organizations, and three community members.

The appointment of representatives and alternates for the various associations/organizations takes place every four years, as their term of office coincides with the term of the Board.

KEY CONSIDERATIONS:

3. At the September, October and November 2018 meetings of the Special Education Advisory Committee, the members were advised of the requirement for their group to nominate a representative and alternate for confirmation by the Board at its organizational meeting. Emails were also sent to association and organization presidents advising them of this requirement.

For those associations/organizations who have not nominated a representative or those where the alternate member remains vacant, a further report and recommendation will be brought to the Board for approval.
