1. Call to Order -- Chair of the Board

Chair Scott called the public meeting to order at 7:01 p.m. She acknowledged that the meeting is taking place on unceded Algonquin Territory and thanked the Algonquin Nations for hosting the meeting on their land.

2. Approval of the Agenda

Moved by Trustee Blackburn, seconded by Trustee Hough, THAT the agenda be approved.

3. <u>Delegations</u>

There were no delegations.

4. Advisory Committee Presentation

4.1 Advisory Committee on the Arts (N. Dean, Chair)

Ms. Dean, the chair of the Advisory Committee on the Arts (ACA), noted that art comes in many forms including, drama, dance, music, visual arts, literary, and everything creative.

Ms. Dean advised that the ACA is an independent advisory committee that works to provide vibrant arts programming for OCDSB students. The ACA supports and encourages arts education for OCDSB students and acts as a liaison between the OCDSB, arts institutions and organizations at the local, regional, provincial, and national level. ACA also liaises between the OCDSB, business, and post-secondary community.

Ms. Dean advised that the COVID-19 pandemic provided an opportunity to deliver arts programs in creative ways; however, performance arts were negatively impacted. The ACA has been discussing methods to increase arts experiences while examining how to support and improve arts-informed pedagogy. The ACA has discussed the need to ensure there is adequate space and time for arts experiences for OCDSB students.

Ms. Dean noted that the ACA will be collaborating with the Advisory Committee on Equity (ACE) to ensure inclusive and equitable arts programs.

Ms. Dean advised that arts educators require support to provide curriculum focused arts experiences. ACA has discussed student engagement and enrolment concerns in future arts programs.

Ms. Dean advised that the ACA could be further supported by having the District prioritize arts experiences and other creative opportunities. She added that the ACA would welcome increased resources in staffing, spaces, and other curriculum support to facilitate these arts experiences and to increase the quality of arts programs for students.

The ACA is working to increase accountability to support the Indigenous, Equity, and Human Rights Roadmap. Ms. Dean noted that she can be contacted for more information.

In response to a query from Trustee Bell on what is needed to increase access to arts programs in schools, Ms. Dean advised that each school needs dedicated art spaces and resources and noted that budget

information for arts materials could be presented earlier in an effort to help the arts programs plan for the next school year.

Chair Scott encouraged trustees to attend ACA meetings.

5. Report from the Board (In Camera)

The Board met in camera this evening and Vice-Chair Penny reported that there were no recommendations.

6. Briefing from the Chair of the Board

Chair Scott reported that on 21 April 2022, the Ontario government announced it would be committing over \$19.2 million to fund the construction of a new OCDSB elementary school with child care in Ottawa's Findlay Creek community. She noted that the new school will serve 674 students from Kindergarten to Grade 8 and will also include child care with 39 spaces for toddler and preschool-aged children. Chair Scott thanked the Ontario government on behalf of the Board for committing to this important project and acknowledged the families, students, trustees, and community members who have advocated for this school.

Chair Scott reported that the nomination period for school board trustee candidates commences on 2 May 2022, and the municipal election is to be held on 24 October 2022. She advised that the period to register as a candidate runs until 19 August 2022 and candidates must file their nominations through the City of Ottawa Elections Office. Information about the municipal election can be found on the City of Ottawa Elections website.

Chair Scott wished a Blessed Eid to all in the community who are celebrating.

7. Briefing from the Director

Director Williams-Taylor reported that the OCDSB communicated with families and staff regarding changes in the District's approach to social media. Director Williams-Taylor noted her appreciation of the communications value of social media, but expressed concern regarding the increased use of social media as a tool for bullying, intimidation and hate. She noted that as a learning organization, the OCDSB has a responsibility to curate a safe and respectful online community for students, families, staff, and the broader public.

Director Williams-Taylor reported that the OCDSB continues to navigate challenges due to staffing shortages, which has impacted the operation of the Extended Day Program. She noted that the program will not be operating in 10 schools from 2 May 2022 through to 4 May 2022. Director Williams-Taylor advised that the service is expected to resume 5 May 2022. Information has been provided to families affected by these challenges.

Director Williams-Taylor reported that the Ministry of Education has approved the OCDSB school year calendar for the 2022-2023 school year. She noted that the

full calendar will soon be available on the OCDSB website and key dates were communicated in recent messaging to families, students and staff.

8. COVID-19 Update

Associate Director Reynolds reported that the District continues to face operational impacts due to the challenge of securing replacement staff. He noted that the number of class closures have reduced since the Easter long weekend.

In response to a query from Trustee Jennekens regarding the procedure for students and staff returning to in-person schools after five days of isolation from COVID-19, Associate Director Reynolds noted that providing a negative COVID-19 test is not required by provincial or local health authorities. He noted that individuals attending District buildings are required to follow the daily COVID-19 screening tool and act accordingly.

An amendment moved in substitution by Trustee Blackburn, seconded by Trustee Jennekens,

THAT section 9.3 of Policy *P.125.SCO*, *School District Code of Conduct* be revised as follows:

"All allegations of Bullying, Harassment, Sexual or Gender-based Harassment, and Hate-related behaviour must be acknowledged upon receipt, be taken seriously and dealt with in a timely, sensitive, and supportive manner as set out in procedure."

Trustee Blackburn noted that the amendment would address issues with having a prescriptive timeline embedded in the policy. She noted that removing a set timeline within the policy would ensure that each allegation is investigated thoroughly with the time required without rushing the process to meet a deadline.

Superintendent McCoy advised that compliance with a timeframe of 20 days for responding to and addressing an allegation can depend on a variety of factors, including the complexity of the matter and the availability of those involved. Superintendent McCoy stressed that staff take allegations seriously and attempt to resolve them in a timely manner with a clear and fair process; however, some factors are outside the control of the District, such as employees absent due to medical reasons. She added that additional details will be incorporated into the procedure to ensure timely responses to the parties involved in an allegation.

Trustee Lyra Evans noted that the language used in section 9.3 of Policy *P.125.SCO* before the amendment, acknowledged potential factors when not able to meet the set timeline. She noted that the timeline sets an expectation and would allow the public to understand an appropriate time to escalate an allegation.

Some trustees noted their appreciation for the accountability that the set timeframe of 20 days could provide; however, it was noted that timeframe details would be better suited within the procedures. Some trustees also noted that if the timeframe is in the procedures, it would still provide justification for escalation.

Director Williams-Taylor noted that she would prefer to not have a timeline in the policy as it may encourage staff to limit an investigation to meet a predetermined deadline, thus compromising the quality of the investigation.

In response to a query from Trustee Fisher regarding the lack of clear timeframes for staff to contact those involved in an investigation, Superintendent McCoy noted that the procedures could include clauses that detail regular updates for those involved that still allow for the investigation to proceed. She noted that this would allow the investigation to take the time it requires while allowing those involved to have more frequent updates so as not to feel that their allegation has been forgotten.

Trustee Ellis contended that the 20 day timeframe should remain in the policy to ensure that staff communicate with those involved if the investigation goes past 20 days.

Trustee Blackburn expressed the view that investigations of this nature are complex and that the timeframe of 20 days is unrealistic. She urged

trustees to follow the advice and experience of Superintendent McCoy and Director Williams-Taylor.

Trustee Ellis called point of order, noting that Trustee Blackburn impugned what some trustees thought of the issue at hand.

Trustee Blackburn withdrew her remarks relating to her comment of what she believed some trustees were thinking.
