8. <u>Briefing from the Chair of the Board</u>

Chair Scott reported that the Board Room and Committee Room renovations are complete and that the new Board of Trustees would be sworn in at a public meeting in-person at 133 Greenbank Road on 15 November 2022. Chair Scott expressed that her service as Chair of the current Board has been a pleasure.

Chair Scott provided notice of the following events:

- On 5 November 2022, the Ottawa Carleton District School Board (OCDSB) will host a Parent Conference at Ridgemont High School. The conference includes keynote speaker Dr. Michael Cheng from the Children's Hospital of Eastern Ontario (CHEO) and multiple workshops on important topics for families. She noted that the event will offer sessions in Arabic and Somali;
- The Indigenous, Equity, and Human Rights Roadmap event on 9
 November 2022 at Woodroffe High School provides an opportunity to
 reflect with the community on the OCDSB journey to date and the way
 forward to fulfill commitments outlined in the Indigenous, Equity and
 Human Rights Roadmap. The event will include presentations from
 schools, a student panel, and breakout sessions for participants to share
 their advice and experiences; and
- On 11 November 2022, students will participate in activities to reflect, remember and learn about veterans for Indigenous Veterans' Day and Remembrance Day.

9. Briefing from the Director

Director Williams-Taylor welcomed all newly-elected trustees to the Board and extended her gratitude to the trustees who served the District for the 2018-2022 term.

Director Williams-Taylor reported on the following:

 New and returning trustees will be participating in an extensive orientation program over the coming weeks to learn about the roles and responsibilities of trustees under the Education Act;

- The OCDSB does not have any Canadian Union of Public Employees (CUPE) bargaining units and negotiations between CUPE and the province would not directly affect school board operations. It was noted that there may be a small number of students impacted who are enrolled in specialized programs operated in partnership with the Ottawa Catholic School Board (OCSB) and that families will be contacted directly with more information, as required;
- Elementary schools will be closed on 4 November 2022 for a professional development (PD) Day;
- Director Williams-Taylor congratulated students Zaina Karaki and Kaelyn Aldridge who recently received a Young Leader in Volunteering Award for their work as co-chairs of the Sir Robert Borden High School's Kiwanis KEY club having led fellow students in undertaking numerous community volunteer projects;
- Students, staff and families are invited to participate in a Transgender Day of Remembrance webinar on 17 November 2022; and
