1. <u>Call to Order -- Chair of the Board</u>

Chair Lyra Evans called the public meeting to order at 8:09 p.m.

2. Acknowledgement of Territorial Lands

Chair Lyra Evans acknowledged that the meeting is taking place on unceded Algonquin Homelands and thanked the Algonquin Nations for hosting the meeting on their land.

3. Approval of the Agenda

4. Declarations of Interest

No declarations of interest were filed.

5. <u>Presentation to the Director</u>

Chair Lyra Evans thanked Director Camille Williams-Taylor for her work at the Ottawa-Carleton District School Board (OCDSB) and presented her with a gift as an expression of appreciation on behalf of the Board. Chair Lyra Evans invited Board members to view a video which highlighted Director Williams-Taylor's work as the Director of Education.

Director Williams-Taylor thanked the Board and reflected on her experiences with the trustees and the District, and expressed her deepest appreciation for the learning opportunities and support that she received in this role.

6. Delegations

6.1 Deena Friedman, re Antisemitism at School

Deena Friedman, a grade 12 OCDSB student expressed the view that antisemitism has increased in schools and that Jewish students do not feel safe at school. She called upon the Board to do more to address antisemitism, including educating teachers and administrators to recognize antisemitism when it occurs and to take action to stop it from continuing.

6.2 Susan McGahan, re Support for Jewish Students in the OCDSB

Susan McGahan played a recording of students sharing their lived experiences of being Jewish in OCDSB schools. She expressed the view that the voices of Jewish students are not being heard, and called for more support for Jewish students, including the addition of a Jewish equity coach. Ms. McGahan submitted that educators need to learn how to support Jewish students and that the Board should clearly define antisemitism and adopt the definition of antisemitism put forward by the International Holocaust Remembrance Alliance (IHRA).

6.3 Timothy Daum, re Antisemitism Concerns at the OCDSB

Timothy Daum, a parent of an OCDSB student, expressed concern about antisemitism in OCDSB schools and the need for protection of Jewish students. He expressed appreciation for the efforts the Board has made towards addressing anti-Black racism and recommended the addition of a Jewish equity coach to assist with mandatory training on antisemitism and consequences for hate speech and actions.

6.4 Michael Moskovic, re Antisemitism Concerns at the OCDSB

Michael Moskovic shared a video of a speaker from the recent "Rise Up Ottawa" conference on antisemitism. He noted that his father was a Holocaust survivor and he expressed concern about antisemitism incidents occurring in schools. He called upon the Board to add a Jewish equity coach to address this issue.

6.5 Gladys Zarecki, re Antisemitism in the Public School System

Gladys Zarecki, a retired teacher, expressed concern about antisemitism in schools and the lack of teacher training and student education on antisemitism. She recommended that schools address this topic in a similar manner to what has been provided with respect to combating prejudice against other groups, such as Indigenous, Black, LGBTQ, Islamic and Muslim students.

6.6 Robert Levine, re Safe Environment for Jewish Students

Robert Levine noted a recent incident at an OCDSB school, and expressed the view that a review is required with regard to how schools are addressing antisemitism, including the consequences for acts of hate and discrimination. He recommended the hiring of a Jewish equity coach to address the issue and provide training for staff.

6.7 Josh Korn, re Antisemitism in OCDSB Schools

Josh Korn expressed concern about the rise of antisemitism in OCDSB schools and suggested mandatory antisemitism education for all staff and students. He expressed the view that there should be zero tolerance for antisemitic rhetoric and actions with meaningful consequences for students and teachers who engage in such activities.

6.8 Daud Aden, re Lack of Diversity in Schools

Daud Aden expressed the opinion that there is a lack of diversity among school leaders and staff at the OCDSB, particularly for visible minorities, Black, and Indigenous leaders and staff. He recommended that the Board identify and eliminate barriers to achieving a diverse workforce, and ensure that hiring policies and practices are inclusive.

In response to queries from trustees, Mr. Aden expressed the view that diversity is recognized and measured by what can be observed through OCDSB hiring practices and policies.

8. <u>Briefing from the Chair of the Board</u>

During the briefing, Chair Lyra Evans reported the following:

- The Education Foundation of Ottawa (EFO) is asking for donations to their "Gift a Lift" campaign to aid OCDSB students in need to help them move toward a bright future, a full belly, or a warm winter;
- Parents or students are encouraged to nominate an outstanding educator for the 2023 Prime Minister's Awards. The Prime Minister's Awards recognize excellence in teaching, teaching excellence in Science, Technology, Engineering and Mathematics (STEM), and excellence in Early Childhood Education. Nominations are open until 17 January 2023; and

 Two OCDSB schools were recognized in the CBC Canadian Music Class Challenge. She extended congratulations to Lisgar Collegiate Institute on earning third place in the Senior Instrumental category, and to Bayshore Public School on being a Top 10 finalist in the Primary Vocal category.

- The 2021-2022 Director's Annual Report is available on the OCDSB website and highlights the OCDSB's commitment to student success and achievement. The report also highlights the Districts' success in carrying out the strategic plan and highlights the rich learning that is happening in OCDSB classrooms, the strong sense of community in OCDSB schools, and the work of school teams and system departments to ensure that the OCDSB continues to build on our success.
- The OCDSB will be developing a new strategic plan for 2023-2027. The
 goal is to create a simple, measurable and impactful plan that is
 meaningful to students, staff and community members. An important step
 in the development of the plan is community consultation, which will
 include in-person and virtual opportunities taking place in early 2023,
 including the following large-group consultations:
 - 12 January 2023 at Ottawa Technical Secondary School;
 - 19 January 2023 at Bell High School; and
 - o 2 February 2023 for a virtual session.
- The latest episode of the "In Conversation with OCDSB" podcast discusses how to navigate the digital world with confidence;
- Many families in the OCDSB community will be celebrating holidays or marking important occasions together in December 2022 and early January 2023. Warmest wishes were extended to all who will be observing these and other celebrations throughout the winter holiday season, including:

12.3 Notice of Motion, Re: Appointment of Advisory Committee on Equity Trustees to the Ad Hoc Director Selection Committee, Trustee Bell

Notice of motion having been given, Trustee Bell moved as follows:

WHEREAS the Board is responsible for the selection and appointment of the Director of Education:

WHEREAS the Board, at is inaugural meeting of 15 November 2022, appointed three trustees as members of the Ad Hoc Director Selection Committee;

WHEREAS the Board, at is inaugural meeting of 15 November 2022, appointed Trustees Dickson and Kaplan-Myrth as members of the Advisory Committee on Equity;

WHEREAS Board Policy P.146.HR establishes a commitment to the development and implementation of fair, consistent, transparent, and equitable practices and procedures for recruitment, hiring, and promotion for all positions to improve the ability to achieve and maintain a strong and diverse workforce; and

WHEREAS Section 4.8 d (iv) of P.146.HR further outlines expectations for diverse hiring panels that intentionally reflect a diversity of lived experiences, skill sets, and educational and professional backgrounds;

THEREFORE BE IT RESOLVED

THAT the trustee representatives to the Advisory Committee on Equity (ACE) be appointed as trustee members to the Ad Hoc Director Selection Committee.

Trustee Bell expressed the view that it is important for the Ad Hoc Director Selection Committee to ensure that inclusive hiring policies and practices are followed and that there are no barriers in place to achieving a diverse workforce. The intent is for the trustee representatives to the ACE to participate and oversee the hiring process, including setting parameters and background work.

In response to a query regarding the role of trustees who were not appointed to the Ad Hoc Director Selection Committee, the following information was provided:

- All trustees may attend and participate in meetings of the Selection Committee but only members of the selection committee can vote at selection committee meetings;
- The interview process is open to all trustees wishing to participate;
 and
- The full Board of trustees votes on the recommendation from the selection committee for the appointment of a new Director.

Trustee Scott noted that past practice has demonstrated that the selection committee has worked well by consensus and trustee voices are heard. The committee's role is addressed in policy, is generally housekeeping in nature, and adding members would raise the number required for quorum making it more difficult to manage.

Trustees Dickson and Kaplan-Myrth noted that as ACE representatives they would focus on ensuring the new director understands equity by having lived experiences in dealing with hate and discrimination.

Trustee Blackburn noted that she would participate in the selection committee and would bring her lived experience perspective.

Trustee Bell reiterated the importance of involving the ACE in the selection process.

Trustee Kaplan-Myrth provided formal notice that she would bring a motion before the Committee of the Whole meeting on 17 January 2023 with respect to the establishment of a 1.0 Full-time Equivalent (FTE) Jewish Equity Coach position.

Trustee Scott requested an update from staff with respect to actions taken to address drug use and human trafficking in schools.

Trustee Scott requested that information from Ottawa Public Health (OPH) regarding respiratory diseases and safety precautions be made more accessible through OCDSB media platforms.

In response to a request from Trustee Blackburn for an update on the District's relationship with the Ottawa Police Service (OPS), Director Williams-Taylor advised that school administrators engage with OPS on criminal matters as appropriate and OPS continues to be responsive. There is currently no plan to

bring OPS into schools for presentations, as was done before the Board rescinded its policy on police involvement in schools two years ago.

Trustee Lyra Evans noted the requirement to resolve into an in camera session in order to complete the in camera agenda. Prior to moving to the Trustee Committee Room she called for a vote to continue the meeting past 10:30 p.m.
