1. Call to Order -- Chair of the Board

Chair Lyra Evans called the public meeting to order at 7:27 p.m.

2. Acknowledgement of Territorial Lands

Chair Lyra Evans acknowledged that the meeting is taking place on unceded Algonquin Homelands and thanked the Algonquin Nations for hosting the meeting on their land.

3. Declarations of Interest

No declarations of interest were filed.

4. Report from the Board (In Camera)

The Board met in camera this evening and Vice-Chair Scott reported that there were no recommendations.

6. Briefing from the Chair of the Board

During the briefing from Chair Lyra Evans, the following information was provided:

- The third National Day for Truth and Reconciliation (also known as Orange Shirt Day) will take place on 30 September 2023 to recognize the history and legacy of residential school;
- Rowan's Law Day will take place on 27 September 2023 to raise awareness of concussions;
- The next meeting of Committee of the Whole will take place on 3 October 2023. Agenda action items include a report on capital priorities and a notice of motion regarding the introduction of an Indigenous student trustee; and
- Applications are open for parents and community members to serve on the Board's Parent Involvement Committee. Details are available on the District's website.

7. Briefing from the Director

During the briefing from Director Buffone, the following information was provided:

- The Board will review and update a number of policies this year, including policies on naming schools and the extended day and child care program;
- The Ottawa Student Transportation Authority (OSTA) has reinstated approximately 100 bus routes since the start of the school year by optimizing bus routes and hiring new or returning bus drivers. OSTA is investigating a number of options to increase bus routes;
- The OCDSB will host job fairs on 2 October 2023 and 5 October 2023;
 and
- Friday, 6 October 2023 is a Professional Activity day for elementary and secondary students.

Trustee Kaplan-Myrth noted that bus cancellations have affected many families whose children have no other way of getting to school. She requested that OSTA

clearly communicate measures being taken to address this issue and consider compensation to parents and/or alternative funding sources.

Trustee Scott noted that parents in rural areas without OC Transpo service have been severely affected by bus cancellations and requested that OSTA urgently address the problem, for example, to provide partial, one way busing before or after school.

11.1.a.a Approval of Riverside South Attendance Boundary

A. THAT the new Riverside South SS open in September the year it is completed for occupancy as a grade 7 to 12 secondary school, initially offering grades 7 to 10, to grow a grade per year thereafter until offering a full grade complement;

- B. THAT the boundary of this secondary school (as shown in Appendix B) be drawn from the current 7 to 12 boundaries of Merivale HS, South Carleton HS, Osgoode Township HS, Ridgemont HS, Brookfield HS, and Gloucester HS in accordance with Appendices F, G, H, I, J, L (Attached as Appendix A).
- C. THAT any grade 11 and 12 students (upon opening of the new Riverside South SS) attending Merivale HS, South Carleton HS, Osgoode Township HS, Ridgemont HS, Brookfield HS, and Gloucester HS, shall remain at their current high school with transportation provided if they are eligible under Student Transportation Policy P.127 TRA and Procedure PR.556 TRA;
- D. THAT the boundary for Farley Mowat PS be amended (as reflected in Appendix C) to bring that portion of its current boundary east of the Rideau River into the Steve MacLean PS catchment; all students grade K to 5 will be expected to block move to Steve MacLean PS upon

opening of the new Riverside South SS. Students entering grade 6 upon opening of the new Riverside South SS may remain at Farley Mowat PS with all transportation provided if they are eligible under Student 7 Transportation Policy P.127 TRA and Procedure PR.556 TRA (Attached as Appendix B); E. THAT the grade structure for Steve MacLean PS be amended to a K-6 grade format and the boundary be amended as reflected in Appendix D (Attached as Appendix C);

- F. THAT the grade structure for Vimy Ridge PS be amended to a K-6 grade format and the boundary be amended as reflected in Appendix E (Attached as Appendix D);
- G. THAT the boundary for South Carleton HS be amended as reflected in Appendix F (Attached as Appendix E);
- H. THAT the boundary for Osgoode Township HS be amended as reflected in Appendix G (Attached as Appendix F);
- I. THAT the boundary for Merivale HS be amended as reflected in Appendix H (Attached as Appendix G); J. THAT the boundary for Ridgemont HS be amended as reflected in Appendix I (Attached as Appendix H); K. THAT the boundary for Brookfield HS be amended as reflected in Appendix J (Attached as Appendix I); L. THAT the Grade 7 to 8 English Program with Core French and Early French Immersion Attendance boundary for Kars on the Rideau PS be amended as reflected in Appendix K (Attached as Appendix J); M. THAT the boundary for Gloucester HS be amended as reflected in Appendix L (Attached as Appendix K); N. THAT students in the area bounded by Rideau Road to the north, Limebank Road to the east, Mitch Owens to the south, and the Rideau River to the west that are impacted by the opening of the new Riverside South SS,
 - i. Students residing in this area upon opening of the new Riverside South Secondary School, be given a one-time option to remain at / choose to attend Merivale HS, Osgoode Township HS, or South Carleton HS and be provided transportation if they are eligible under Student Transportation Policy P.127 TRA and Procedure PR.556 TRA; ii. Students not residing in this area upon opening of the new Riverside South SS, be directed to

attend Osgoode Township HS, or South Carleton HS and be provided transportation if they are eligible under Student 8 Transportation Policy P.127 TRA and Procedure PR.556 TRA; and

O. THAT any student on a cross boundary transfer at a school whose program cohort is being relocated to another school as a result of approved recommendations in Report 23-048 be allowed to move with their program cohort without having to reapply for a transfer.

A. THAT, after the Board receives an update regarding air quality standards in the 2023-2024 school year, the Chair write to the Minister of Education, including the Ontario Public School Boards' Association, the Minister of Health, the Minister of 11 Municipal Affairs, Ontario Chief Medical Advisor and Chair of Public Health Board, requesting:

- 1. Updates to air quality standards and guidance for public school buildings to support schools in creating the safest possible learning environments;
- 2. Dedicated capital and operating funding envelopes for reducing the spread of illness in schools. These are to: i. Build from previous provincial investments to support ventilation improvements to build long-term improvements to air quality in all our schools; and ii. Support continued public health promotion activities in and around schools, in partnership with Ottawa Public Health.
- B. THAT the Director present a report to the Board, prior to the end of 2023 on:
 - 1. Ventilation-related investments, challenges and opportunities; and
 - 2. Other opportunities related to reducing respiratory viruses in schools.

12. <u>Matters for Discussion</u>

12.1 Report from OPSBA Representatives (if required)

Trustee Jennekens advised that she and Trustee Scott attended the Ontario Public School Boards Association (OPSBA) Board of Directors meeting on 23-24 September 2023. She noted that OPSBA's Advocacy Day meeting with Members of Provincial Parliament (MPPs) will take place at Queen's Park on 27 November 2023. Local Government Week will take place on 15-20 October 2023 to help raise awareness of the role local government plays in communities. This year, OPSBA will recognize and advocate for civics classes for students in Grades 5 and 10.

12.2 Ministry Initiatives

12.2.a Disposition of Surplus Property and Schools in Shared Sites

Associate Director Gerrior provided an overview of the memo regarding disposition of surplus property and schools in shared sites. He highlighted that school boards are permitted to sell properties that would not be required for pupil accommodation for the next 10 years at fair market value. A new regulation is proposed with respect to the requirements to acquire a school site that would be shared with an entity other than another school board, a municipality or child care centre.

Trustee Scott inquired whether a school site that is shared with an entity other than another school board, a municipality or child care centre, could include multi-use residential or commercial space, for example, a school located on the ground floor of a residential building. Staff agreed to seek further information and provide some examples.

13. Matters for Information

13.1 Ottawa School Transportation Authority (OSTA) Update

Trustee Lee advised that OSTA continues to reinstate as many bus routes as possible and provide daily updates on their website. On 27 September 2023, some routes will be reinstated in Stittsville and West Carleton. OSTA understands that parents/guardians are frustrated and is working diligently to explore all options.

Trustee Presley expressed concern about some of the walking distances that may require students to circumnavigate pathways that are not accessible.

Trustee Aziz noted the difficulties for families in rural areas and expressed her disappointment that municipal and provincial governments have not done more to provide assistance.

Trustee Kaplan-Myrth noted that some students, who must travel across the District to attend specialized system programs at Canterbury High School and Glebe Collegiate Institute, are unable to get to their school. She asked how long the District has known about the transportation problems and what actions will be taken in the future to ensure it does not happen again. Director Buffone noted that many school bus drivers did not confirm their intention to continue until after school started, and negotiations with bus operators is ongoing.

Trustee Scott advised that of the 68 bus routes in the western area of the District were cancelled and to date, only 12 routes have been restored. Many families are facing hardships as a result of bus cancellations and are frustrated with the lack of information on when full service will be restored.

Trustee Jennekens noted that public transportation is not available in some rural areas and the lack of school bus transportation is having a negative impact on families.

Trustee Bell submitted that those who have the power to resolve the transportation issues should have a plan in place to ensure these issues to not happen again.

Trustee Lee advised that a concern was raised at the Committee of the Whole meeting on 12 September 2023 with respect to a seven-year-old child who was dropped off at a school bus stop without someone being there to meet her. OSTA policy provides that students under the age of six are not to be left without a parent/guardian to greet them. For children six and older, parents have been advised of the time that the school bus is expected to arrive at their child's stop and there is no requirement for the driver to remain at the bus stop with the student. School bus delays are posted on the OSTA website.

14. New Business -- Information and Inquiries

Trustee Kaplan-Myrth noted the rising rates of COVID-19, RSV, and flu and requested that staff and students be reminded to wear a mask indoors. Director Buffone advised that staff would follow up with Ottawa Public Health on appropriate messaging for inclusion in updates to parents/guardians and staff.
