1. Call to Order - Vice-Chair of the Board

6. Matters for Discussion:

6.1 Report 24-002, New Education Development Charges By-Law (2024-2029) - Required Public Meeting and Background Study (R. Gerrior)

Your Committee had before it Report 24-002 providing information to support a legislatively required meeting in order to inform the public about the Board's Education Development Charge (EDC) proposals and to solicit input regarding a proposed new by-law which would cover the period between 2024-2029.

General Manager Carty-Ostafichuk introduced Consultant Cynthia Clarke from Quadrant Advisory Group Limited who was in attendance to answer questions on the report.

During discussion and in response to queries, the following points were noted:

- EDCs may not be collected for the purchase of additional land to build an extension on an existing school unless it can be demonstrated that the growth in student numbers exceeds the District's capacity;
- Trustee Lyra Evans expressed her support for the collection of differentiated EDC rates for apartments;
- No school boards have adopted differentiated rates for the collection of EDCs as it could detrimentally affect the maximum funding available;
- School boards may increase service rates per unit over the life of the bylaw;

- The majority of school boards have adopted a residential/nonresidential percentage split of 80/20;
- Housing forecasts are calculated by the City of Ottawa using development applications in process, actual student data provided by school districts, and property assessment data to determine the number of students per household. There are no projections or assumptions used to calculate these numbers;
- On average, apartments have fewer students because they typically include housing for seniors;
- The EDC By-Law will be presented to the Committee of the Whole on 5 March 2024 for approval at a Special Board meeting to follow on 5 March 2024;

Trustee Jennekens assumed the Chair.

- An advertisement was published in the Ottawa Citizen on 15
 December 2023 providing notice of the Special Committee of the
 Whole meetings on 16 January 2024. The EDC Background Study
 was posted on the District's website and hard copies were provided
 to key stakeholders in the development community; and
- An additional input should be directed to General Manager Carty-Ostafichuk prior to 5 March 2024.
