# 6. Briefing from the Chair of the Board

During the briefing from Chair Scott, the following information was provided:

- On behalf of the Board, Chair Scott presented to the provincial Standing Committee on Finance and Economic Affairs as part of the Ottawa-Carleton District School Board (OCDSB)'s efforts to advocate for fair funding for public education in the 2024 Ontario budget. The presentation highlighted the increased costs of special education, mental health supports, student transportation, maintenance and building of schools, cybersecurity, and staff replacement costs;
- The Education Foundation of Ottawa's (EFO's) annual Toonie Tuesday fundraising campaign will take place on 27 February 2024. Funds raised will support the EFO's work to help OCDSB students in need; and
- The OCDSB is seeking an Indigenous Community Member to serve as an alternate member on the Special Education Advisory Council (SEAC). The alternate Indigenous representative will advocate for the interests of Indigenous students with special education needs. The deadline to apply has been extended to 29 February 2024.

# 7. Briefing from the Director

During the briefing from Director Buffone, the following information was provided:

 February is Black History Month to celebrate Black culture and history and the significant contributions Black Canadians have made to this country. The OCDSB Family and Community Engagement team will host an event on 24 February 2024 at Longfields-Davidson Heights Secondary School to honour Black excellence;

- Black History Ottawa recently presented their President's Award to the OCDSB at their annual Community Builder Awards ceremony in recognition of the District's involvement with the Ubuntu Collective project. Two awards were granted, one to the District and one to Executive Officer Michele Giroux for her work as chair of the Ubuntu Collective;
- The student transfer application period for both elementary and secondary students is open until 9 February 2024; and
- Glebe Collegiate Institute student, Danella Nduwayo, has been selected from among 5,200 applications to be one of 90 2024 Loran Finalists. National interviews will take place in Toronto in February for a chance to be named one of 36 Loran Scholars. Winners who will receive approximately \$100,000 over four years of undergraduate study.

# 8.1 Andrea Chandler, re Zone 9 Representation

Andrea Chandler, a resident of Zone 9, expressed concern about the sanctions imposed on Trustee Kaplan-Myrth for violating the Board's Code of Conduct, as they affect her ability to advocate for her constituents during the time she is prohibited from attending Board and Committee of the Whole meetings. She expressed the opinion that this violates her right to political representation and residents of Zone 9 are disadvantaged compared to residents in other zones. She expressed the opinion that the Code of Conduct is flawed and could be misused in the future to exclude trustees indefinitely.

In response to a request for staff comment, General Counsel Sinclair advised that the Code of Conduct is in line with the *Education Act* which requires school boards to have a Code of Conduct and to include sanctions that may be imposed if a Board member violates the Code. He added that other parliaments also have options to suspend their members for conduct reasons.
