1. Opening (Algonquin Knowledge Keeper, Monique Manatch)

5.1 <u>Elementary Program Review (P. Buffone)</u>

Director Buffone provided an overview of Report 24-052, Elementary Program Review, which the Board of Trustees approved at the Committee of the Whole (COW) meeting on 2 April 2024.

During the discussion and in response to queries, the following points were noted:

- Trustees and senior staff identified that a program review at the elementary level was a priority focus for the District as part of the renewed strategic plan;
- The District plans to undertake a consultation process between April and June 2024 to inform a potential program model(s) conceptualized for recommendation to trustees in the fall of the 2024;
- It was noted that a disproportionate number of students that are marginalized or facing other barriers are streamed into the English program track at a young age; and
- It was noted that the renewal of the Indigenous, Equity and Human Rights Roadmap will assist in the development of culturally-relevant and responsive educational practices.

Facilitator Manatch requested that this item be added to the 16 May 2024 IEC agenda for further discussion.
