1. Call to Order

Associate Director Gerrior called the public session to order at 7:00 p.m.

2. <u>Acknowledgement of Territorial Lands</u>

Associate Director Gerrior acknowledged that the meeting is taking place on unceded Algonquin Homelands and thanked the Algonquin Nations for hosting the meeting on their land.

3. Approval of Agenda

6. <u>Associate Director's Report</u>

Associate Director Gerrior reported the following:

b. <u>Business Arising</u>

7.3 Report 24-126, Draft 2023-2024 Consolidated Financial Statements (R. Gerrior)

Your Committee had before it Report 24-126, seeking approval of the draft 2023-2024 Consolidated Financial Statements.

Associate Director of Business Gerrior noted that the statements include the activity and balances of the Ottawa-Carleton Education Network (OCENET), school generated funds (SGF) held by individual schools and school councils,

and the Ottawa Student Transportation Authority (OSTA). The OCDSB is posting an unappropriated deficit of \$12.1 million which is mostly attributed to the impact of the repeal of Bill 124 which limited public sector workers' compensation increases to a maximum of one per cent a year for three years.

7.5 Report 24-132, Audit Committee Annual Report for 2023-2024 (R. Gerrior)

Your Committee had before it Report 24-132, seeking approval of Report 24-132 as the 2023-2024 annual report of activities for submission to the Board in accordance with *Ontario Regulation 361/10*, *Audit Committees*.

Associate Director Gerrior noted that the Audit Committee met five (5) times during 2023-2024 to review the draft financial statements, liaise with the external and internal auditors, and work on educational assistant deployment engagement, follow-up procedures on past audits, safe schools, and legislative requirements. The Audit Committee also reviewed financial projections, risk management activities, regulatory compliance, and provided oversight of internal controls and regulatory compliance reporting.

8. Matters for Discussion

8.1 Report 24-127, Analysis of the District's 2023-2024 Financial Results (R. Gerrior)

Your Committee had before it Report 24-127, providing for discussion, information regarding the District's financial results for the year ended 31 August 2024.

Associate Director Gerrior noted that the District's actual operating deficit is \$12.1 million which is primarily due to wage increases, and funding shortfalls for Bill 124 payouts. The cost of replacement workers continues to be a problem for the District, as does rising costs for school operations, fluctuating student registration, inflationary cost increases, maintenance and portable moves, and the lack of reserves. Associate Director Gerrior suggested that the Board continue its advocacy efforts in the areas of replacement workers and special education.

Associate Director Gerrior noted that the Ministry of Education will expect the District to have a financial recovery plan that could possibly include fundamental program changes. Rebuilding the financial reserves will also need to be a priority during the budgeting process.

8.2 RIAT Update

Genevieve Segu provided an update on the activities of the Regional Internal Audit Team. She noted that they are making progress on the safe schools initiative and gathering data from several similar sized school boards for comparison. It is estimated that a report on the project will be available in January 2025. She also noted that Part 2 of the reallocation initiative has been postponed, and that a regional workshop on strategic risk assessment was held.
