# **REVISIONS TO POLICY P 135 CON - COMMUNITY USE OF SCHOOLS**

# **PURPOSE:**

To discuss the proposed revisions to Policy P 135 CON - Community Use of Schools.

# STRATEGIC LINKS:

1. As part of the scheduled policy review process, staff conducted an assessment to determine whether any existing policies required revision. Policy P 135 CON -Community Use of Schools was last updated on 3 October 2007 and is now considered outdated. A revised version of the policy is proposed, as attached, to better align with current priorities and practices. The updated policy reflects and supports the principles of good governance and responsible resource use, as articulated in the Ottawa-Carleton District School Board's 2023–2027 Strategic Plan.

#### CONTEXT:

2. The review of Policy P 135 CON - Community Use of Schools was required as it was out of date, according to the Ministry guidelines for policy review. A review of the policy was conducted by staff to align the policy with current District practices and commitments, to clarify language, and to reflect up-to-date District formatting.

Throughout the policy	Clauses were removed which no longer reflect District practice. Adjusted phrasing for clarity.
