6. Discussion Items

6.1 Report 25-035: Financial Sustainability Plan and Fiscal Year 2025/2026 Budget Landscape (R. Gerrior)

Your Committee had before it Report 25-035 to discuss the current financial landscape of the Ottawa-Carleton District School Board (OCDSB) and present the District's Financial Sustainability Plan.

During discussion, the following action items were noted:

- Director Buffone committed to providing a list of budget items created by Board motions, such as, Summer Learning Program, Green Bin Program, equity coaches, and their current costs;
- Director Buffone committed to providing information on the annual cost of dealing with legal and complaints-related matters;
- Director Buffone committed to providing a list of budget reductions that have already been approved this year, for example, academic staffing decisions; and
- It was requested that proposed budget reductions be clearly identified as either a program or service, whether they are mandated and funded by the Ministry of Education (MOE) or discretionary, and whether or not they will be combined, absorbed or amalgamated with other programs or services, or eliminated altogether.
